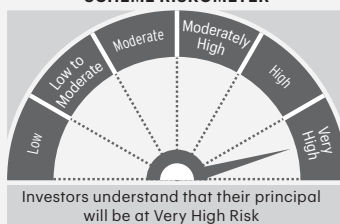

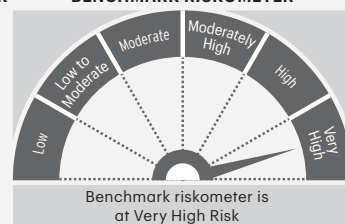
SCHEME RISKOMETER
